INDICATION

Koselugo is a prescription medicine that is used to treat children 2 years of age and older with neurofibromatosis type 1 (NF1) who have plexiform neurofibromas that cannot be completely removed by surgery. It is not known if Koselugo is safe and effective in children under 2 years of age.

SELECT IMPORTANT SAFETY INFORMATION

Serious side effects include: heart problems, eye problems, severe diarrhea, skin rash, muscle problems (rhabdomyolysis), embryo-fetal toxicity.

Most common side effects include: vomiting, stomach-area pain, nausea, dry skin, muscle and bone pain, feeling of tiredness or lacking energy, fever, sores in your mouth, headache, redness around fingernails, itching.

IMPORTANT SAFETY INFORMATION

What are the possible side effects of Koselugo?

Koselugo may cause serious side effects, including:

- **Heart problems.** Koselugo can lower the amount of blood pumped by your heart, which is common and can also be severe. Your healthcare provider will do tests before and during treatment to check how well your heart is working. Tell your healthcare provider right away if you get any of the following signs or symptoms: persistent coughing or wheezing, shortness of breath, swelling of your ankles and feet, tiredness, increased heart rate.

IMPORTANT SAFETY INFORMATION

What are the possible side effects of Koselugo? Koselugo may cause serious side effects, including (cont'd):

- **Eye problems.** Koselugo can cause eye problems that can lead to blindness. Your healthcare provider will check your vision before and during treatment. Tell your healthcare provider right away if you get any of the following signs or symptoms: blurred vision, loss of vision, dark spots in your vision (floaters), other changes to your vision.

Koselugo CoPay Program

If you have commercial insurance, this program may be able to help cover some out-of-pocket treatment costs.

To be eligible, you must:

- ✓ Be signed up for patient services through OneSource
- ✓ Have commercial insurance
- ✓ Be prescribed Koselugo for an FDA-approved indication
- ✓ Reside in the United States or its territories



If you have Medicare, Medicaid, or another federal- or state-funded insurance plan, we can connect you to third-party resources that may be able to help with financial assistance.

IMPORTANT SAFETY INFORMATION

What are the possible side effects of Koselugo?

Koselugo may cause serious side effects, including (cont'd):

- **Severe diarrhea.** Diarrhea is common with Koselugo and can also be severe. Tell your healthcare provider right away the first time that you get diarrhea during treatment. Your healthcare provider may give you medicine to help control your diarrhea and may tell you to drink more fluids.
- **Skin rash.** Skin rashes are common with Koselugo and can also be severe. Tell your healthcare provider if you get any of the following signs or symptoms: rash that covers a large area of your body, peeling skin, blisters.



Tips for Taking Koselugo

Twice-daily Koselugo should be taken—with or without food—approximately the same time each day, about 12 hours apart.

- **Koselugo capsules must only be swallowed whole with water. They must not be chewed, dissolved, or opened**
- **If your child misses a dose, they should take it as soon as you remember.** If it is less than 6 hours before the next scheduled dose, give the next dose at the regular time. Do not make up for the missed dose
- **If your child vomits at any time after taking Koselugo,** they should not take an additional dose. The next dose should be taken at the regular time

It's important to give Koselugo exactly as your child's healthcare provider prescribes and keep to a dosing schedule that fits best with your child's daily routine.

IMPORTANT SAFETY INFORMATION

What are the possible side effects of Koselugo?

Koselugo may cause serious side effects, including (cont'd):

- **Muscle problems (rhabdomyolysis).** Muscle problems are common with Koselugo and can also be severe. Treatment with Koselugo may increase the level of a muscle enzyme in your blood called creatine phosphokinase (CPK) and may be a sign of muscle damage. Your healthcare provider should do a blood test to check your muscle enzyme levels of CPK before you start taking Koselugo and during treatment. Tell your healthcare provider right away if you get any of the following signs or symptoms: muscle aches or pain; muscle spasms and weakness; dark, reddish urine.

Your child's healthcare provider will fill out their section of the enrollment form, which includes your child's prescription for KOSELUGO® (selumetinib).

NEXT STEPS

- 1** Once the enrollment form has been submitted, OneSource will reach out to you and your child's healthcare provider's office to confirm we have all the information we need.
- 2** Then OneSource will review your benefits, including out-of-pocket costs and plan options, and provide information on financial assistance.
- 3** Your child's healthcare provider will seek prior authorization from your insurance (if applicable) and place the order for Koselugo.
- 4** Your child will receive their Koselugo treatment, and OneSource will reach out to you and your child with ongoing support.

After you make a treatment plan with your child's healthcare provider, OneSource is here to provide personalized support along the way.

✓ Support with insurance coverage and access to treatment

We're here to help if you or your child's healthcare provider needs information on insurance options, resources, or treatment support. We can also provide information on available programs that may be able to help with out-of-pocket costs.

✓ Help avoiding interruptions in treatment

Life happens. That's why we're here to work with your healthcare provider to help your child stay on track with treatment while traveling, moving, changing insurance, or experiencing other life events.

IMPORTANT SAFETY INFORMATION

Before taking Koselugo, tell your healthcare provider about all your medical conditions, including if you:

- have heart problems.
- have eye problems.
- have liver problems.
- are pregnant or plan to become pregnant. Koselugo can harm your unborn baby. Your healthcare provider should verify if you/your partner are pregnant before beginning treatment. Ensure you/your partner use effective birth control (contraception) during treatment and for 1 week after your last dose if there is possibility pregnancy could occur. Tell your healthcare provider right away if you/your partner think you may be pregnant.

FREQUENTLY ASKED QUESTIONS

When you have questions, we're here to help find the answers.

Q If I'm not enrolled in OneSource™, can they still help answer my questions?

Yes. OneSource is available to answer questions and provide you with educational materials related to your child's condition or treatment with KOSELUGO® (selumetinib). We have a team of Patient Education Managers (PEMs) who host treatment education sessions and may be able to come talk to you in person. Some services, such as contacting your healthcare provider or navigating your health insurance coverage, may require enrolling in the program.

Q My child has just been diagnosed with NF1 PN. How can I learn more about their condition?

Our team is specially trained on your child's condition. Call us and we can provide you with educational materials and other useful resources. Our Patient Education Managers (PEMs) can also provide you with in-person education. Remember, information from our specialists does not replace the medical advice of your child's healthcare provider.

Q How are Onco360, OneSource, and AstraZeneca connected?

OneSource is part of Alexion, the rare disease unit of AstraZeneca (AZ). AZ is the manufacturer of Koselugo. Onco360® is the specialty pharmacy that provides this product. Both Onco360 and OneSource can offer you services and support for Koselugo. To contact Onco360, visit Onco360.com or call 1.877.662.6633.

IMPORTANT SAFETY INFORMATION

Before taking Koselugo, tell your healthcare provider about all your medical conditions, including if you (cont'd):

- are breastfeeding or plan to breastfeed. It is not known if Koselugo passes into your breast milk. Do not breastfeed during treatment and for 1 week after your last dose. Talk to your healthcare provider about the best way to feed your baby during this time.

Tell your healthcare provider about all the medicines you take, including prescription, over-the-counter medicines, vitamins, or herbal supplements. Especially tell your healthcare provider if you are taking aspirin, blood thinners, or other medicines to treat blood clots. Koselugo contains vitamin E, which may increase risk of bleeding.

Q What happens if my insurance or situation changes?

Your Case Manager can help your child avoid interruptions in treatment when they experience changes in insurance coverage or other life events such as moving or traveling. Call us and we will work with you and your child's healthcare provider so that the transition goes smoothly.

Q What will my out-of-pocket costs be?

OneSource can help you understand your insurance coverage and estimated out-of-pocket costs for your child's Alexion treatment. We can also provide information about options for accessing treatment regardless of your insurance coverage.

Q Does OneSource provide any financial assistance?

The Koselugo CoPay Program may help cover some out-of-pocket treatment costs for eligible patients. If you have Medicare, Medicaid, or another federal- or state-funded insurance plan or if you don't qualify for the CoPay Program, we can connect you to third-party resources that may be able to help with financial assistance. What should I avoid while taking Koselugo?

Do not drink grapefruit juice, eat grapefruit, or take supplements with grapefruit or St. John's Wort during treatment.

Most common side effects include: vomiting, stomach-area pain, nausea, dry skin, muscle and bone pain, feeling of tiredness or lacking energy, fever, sores in your mouth, headache, redness around the fingernails, itching.

These are not all the possible side effects of Koselugo. Call your healthcare provider for medical advice about side effects.
